SAINT LUCIA

STATUTORY INSTRUMENT, 2008, No. 43

[24th March, 2008]

The Minister responsible for International Financial Services in the exercise of the powers conferred by section 114 of the International Partnership Act 2006, No. 23 makes these Regulations:

Short title

1. These Regulations may be cited as the International Partnership (Forms and Fees) Regulations 2008.

Interpretation

2. In these Regulations —

"Act" means the International Partnership Act 2006, No. 23.

Application for registration as an international partnership

3. Two or more persons applying to register an international partnership pursuant to section 8 or 14 of the Act, shall apply by causing the registered agent named in the articles to submit to the Registrar a registration form and a memorandum as prescribed in Forms 1 or 2 of the First Schedule, together with the annual registration fee prescribed in the Second Schedule.

Certificate of registration for international general partnership

4. A certificate of international general partnership issued pursuant to section 9 of the Act shall be in the form prescribed in Form 3 of the First Schedule.

Certificate of international limited partnership

5. A certificate of international limited partnership issued pursuant to section 15 of the Act shall be in the form prescribed in Form 3 of the First Schedule.

Application to register amendment to memorandum

6. An application to register an amendment to the memorandum pursuant to section 10 or 16 of the Act shall be in the form prescribed in Form 4 of the First Schedule.

Application to register change of registered office or a change of registered agent

7. An application to register a change of registered office or a change of registered agent pursuant to section 10 or 16 of the Act shall be in the form prescribed in Form 5 of the First Schedule.

Application to reserve a name for future adoption

8. An application to reserve a name for future adoption pursuant to section 12 or 18 of the Act shall be in the form prescribed in Form 6 of the First Schedule.

Application to renew registration

9. In order to renew registration, an application in the form prescribed in Form 7 of the First Schedule shall be submitted to the Registrar, upon payment of the annual registration fees payable pursuant to section 96 of the Act.

Application for certificate of good standing

10. In order to obtain a certificate of good standing pursuant to section 103 of the Act, an application in the form prescribed in Form 8 of the First Schedule shall be submitted to the Registrar.

Certificate of good standing

11. A certificate of good standing made pursuant to section 103 of the Act shall be in the form prescribed in Form 9 of the First Schedule.

Application to inspect the register

12. In order to inspect the register pursuant to section 104 of the Act, an application in the form prescribed in Form 10 of the First Schedule shall be submitted to the Registrar.

Fees

13. The fees payable pursuant to sections 8, 9, 11, 12, 15, 16, 17,18, 96, 97, 98, 99, 100, 103, 104 and 105 of the Act are as prescribed in the Second Schedule.

A limited partnership must have the words "International Limited Partnership" or the letters 'ILP' as part of the name.

Partnership is either general or limited.

In a limited partnership this declaration statement must be included.

- (1) Where registration of an international partnership takes place between -
- (a) the 1st day of January and the 31st day of March or on either of these dates, the registration fee payable at the time of registration shall be the annual fee;
- (b) the 1st day of April and the 30th day of June or on either of these dates, the registration fee payable at the time of registration shall be the annual fee reduced by twenty-five percent;
- (c) the 1st day of July and the 30th day of September or on either of these dates, the registration fee payable at the time of registration shall be the annual fee reduced by fifty percent;
- (d) the 1st day of October and the 31st day of December or on either of these dates, the registration fee payable at the time of shall be the annual fee reduced by seventy-five percent;
- (2) The annual fee shall be paid on or before the 5th day of January in every year following the registration of the international partnership.
